# **Aston Martin Lagonda Global Holdings plc**

("Aston Martin Lagonda", the "Company" or the "Group")

#### Launch of Notes Offering and New Revolving Credit Facility by its Subsidiaries

Aston Martin Lagonda Global Holdings plc (the "Company") announces that its subsidiary, Aston Martin Capital Holdings Limited (the "Issuer"), is today launching an offering of £1,140 million (equivalent) aggregate principal amount of senior secured notes due 2029 (the "Notes").

The Company further announces that the issuer has agreed with certain of its existing lenders to enter into a new super senior revolving credit facility agreement, pursuant to which the lenders have agreed to increase their binding commitments by circa £70 million to £170 million, subject to consummation of the Notes offering.

If completed, the proceeds from the offering of the Notes, together with cash on balance sheet, will be used to redeem in full the Issuer's existing senior secured notes and second lien split coupon notes, to repay in full the borrowings under its existing revolving credit facility and to pay expenses and fees in connection with the transactions.

The full Annual Report and Accounts for the financial year ended 31 December 2023 is expected to be published on 8 April 2024.
